

## PUBLISHING AGREEMENT (offer)

Federal State Budgetary Educational Institution of Higher Education “Tambov State University named after G.R. Derzhavin – founder, publisher, editorial board of the journal “**Tambov University Review. Series: Philology and Culturology**” registered by the Federal Service for Supervision of Communications, Information Technologies and Mass Communications (Roskomnadzor) (registration certificate number ПИ № ФС77-50435 from 3 July 2012), hereinafter referred to as the “Publisher”, represented by the rector Vladimir Yurevich Stromov, acting in accordance with the Rules of the TSU named after G.R. Derzhavin, of the first part, and

referred to as the “author”, of the second part, have signed this agreement (hereinafter – “Agreement”) as follows.

### 1. SUBJECT OF THE AGREEMENT

1.1. The author gives and Publisher takes the author’s material, corresponding to profile edition of no more than one author's sheet.

Author’s materials are provided in the computer printout (1 sp.) and electronic format Word (\*.doc) and must be initialed by the author with the date, surname, name, middle name and contact information. Author’s materials will not be returned.

According to Federal law from 27.07.2006 № 152-ФЗ “About personal data” Author agrees that FSBEI HE “Tambov State University named after G.R. Derzhavin” for processing, including data collection, classification, accumulation, storage, (updating, modification), use and destruction of provided personal information. This consent is granted for an indefinite period and may be withdrawn by written notice.

Electronic form of presentation different from the format Word (\*.doc) is preliminary coordinated with the Publisher.

1.2. The Publisher selects, reviews, prepares for publication and publish the Author’s data in print and electronic versions of Publishers, including placement on the selected by Publisher and created Internet websites to the access to the on-line publication access from anywhere and at any time.

1.3. The Publisher provides to the Author the ability to produce print articles from out-circulation publication, or get help with e-mail addresses of its official publication on the Internet.

1.4. The Publisher has the right in its sole discretion, without any coordination with Author to enter into contracts and agreements with third parties, aimed at additional measures for the protection of copyright and publishing rights.

1.5. The author conveys copyrighted material under the following conditions:

– **ways to use copyright material** – the publication in the print edition scientific journal “Tambov University Review. Series Humanities” on the net resource of the Publisher on the Internet.

– **use of copyright material under this Agreement shall be free of charge;**

– **territory, where it is permitted to use copyrighted material, - the Russian Federation, foreign countries and the Internet;**

– **duration of the Agreement** – 5 years. After this period the Publisher reserves and the Author confirms Publisher’s perpetual right to continue the placement of copyright material on the Internet in accordance with clause 1.2. of this Agreement.

1.6. The author guarantees that the use by the Publisher provided to them under this Agreement copyright material does not infringe the rights of third parties.

1.7. The author reserves the right to use the provided hereunder copyrighted material on their own, transfer the rights to it under the contract to third parties if this is not contrary to the Agreement.

## **2. ORDER TO SIGN THE AGREEMENT AND ITS TERMS' CHANGES**

2.1. The terms of this Agreement are a public offer in accordance with paragraph 2 of Art. 437 of the Civil Code of the Russian Federation.

2.2. The conclusion of the Agreement by the Publisher is a publication of the text of article in the journal "Tambov University Review. Series Humanities", as well as placement of the text on the Internet.

2.3. The conclusion of the Agreement by the Author, i.e. complete and unconditional acceptance of the terms of the Agreement, is the execution of any of the following actions by the Author:

– the author transfers the copyright material to the Publisher in person, by postal channels and registration by Publisher of copyright material. – completion by the Author of the material on the proposal and transfer to the Publisher the modified material.

2.4. The Publisher has the right to unilaterally change the terms of the Agreement and to adjust its position by posting notice of changes in the Journal and on the website of the journal no more than once a year.
